Kenilworth SNT support Speed Enforcement

Between 19-25 August there was a focus on the supporting a county wide speed enforcement campaign. The purpose of the campaign was to enforce the speed limits for all vehicles and educate motorists to drive at appropriate speeds.

The **HORSEFAIR** on the weekend of the 20th/21st July took place with little disruption to the town or traffic. The traffic management of the event by the site owner and event organiser, following suggestions by a safety advisory group formed by the land owner, the police and local council, largely ensured this success.

Burton Green Community Speed Watch actively supported the Speed Enforcement campaign during the 19-25 August period. In the previous speed awareness campaign Kenilworth SNT managed to achieve 3rd place overall in the county with the help of both the Town and Burton Green teams.

Excess speed is reported as being a contributing factor in over 25% of all fatal road traffic collisions.

PARKING – THINK PEDESTRIAN

The most effective way for parking problems to be resolved is for drivers to THINK before they park.

If you are visiting the **Greenway** at **Burton Green** you need to consider where you are leaving your vehicle so as not to restrict the width of the carriageway for passing vehicles or block drives.

The next **Kenilworth Community Forum** will take place at Kenilworth Sports & Social Club on September 16th commencing at 7pm. The next objectives for policing will be set at this event. So come along and have your say.

Kenilworth Community Forum Objectives for Policing were set on Monday 1st July 2013

Ten Patrols to deter and check on Anti Social Behaviour at the recreational area between Ashdene Gardens, Elmdene Road and the alley between Lime Grove and Brooke Road, this is known by many as "Black Pad".

Five speed enforcement monitoring sessions in Beehive Hill and Red Lane each.

Ten high visibility patrols in Park Hill area. This covers area from Farmer Ward Road to Dencer Drive, up to and including Villiers Road and the Knights Meadow estate.



Kenilworth Half Marathon – takes place on Sunday 1st September 2013 between 10am and 12.30pm. Beware of runners on the roads and allow extra time for your journey. Signs and Marshalls will in place throughout the event course.

Man Arrested following Caravan Theft

Police in Warwickshire are warning caravan owners to make sure they take steps to keep their caravans secure, following a number of thefts in the county in recent weeks.

In the latest incident a caravan was stolen from an address in Malthouse Lane, Kenilworth during Wednesday 21 August.

Activation of a tracker fitted to the caravan traced it to West Drayton, a suburb of West London. A 36-year old man was arrested by The Metropolitan Police. He has since been released on bail pending further enquiries.

In recent weeks another caravan was taken from Kenilworth, one was stolen from Long Itchington and another from near Coventry. None of these vehicles have been recovered.

Anyone who has any information about the theft of the caravan from Malthouse Lane, Kenilworth on 21 August, or information about the theft of any other caravans, is asked to contact the police on 101.

Advice from Warwickshire Police on keeping your caravan safe:

- Fit a tracking device which can be activated if your vehicle is stolen.
- Use good quality wheel clamps or a security post fixed near the front of the "A" frame and the main body (or both)
- Lock the coupling head into a cover using a good-quality hitchlock
- Use locking wheelnuts
- Consider securing each corner steady by using good-quality padlocks with short shackles to prevent thieves from cutting through them.
- Register your caravan with a national caravan owners club. This will help to identify your caravan if it is stolen.
- Have a reliable caravan alarm fitted, and keep it activated, even when parked outside your home.
- If you keep your caravan on the drive outside your home park it with the towing bar towards the house (so it cannot be hitched up without turning it around). Park a vehicle in front of it to prevent it being taken away.
- If you have gates on your drive keep them closed and locked.
- Like any other important documents, keep caravan registration papers in a safe place inside the house. Never leave them in the caravan
- Always lock the caravan doors and windows and keep an accurate photograph, or the original brochure for your caravan, making a note of any distinguishable marks.

Please heed our advice on Car Key Burglaries! Put Car Keys Away – Don't leave them on show or within reach

The temptation is to put your keys down once you get inside your home somewhere you can easily pick them up when you need them next. Often this means a table or shelf near the entrance to your home.

Unfortunately, it's very easy and convenient for 'fishing thieves' who can easily hook the keys up through the letterbox and be away in your cherished motor before you even know your car is no longer outside. If you own a high performance car some thieves are prepared to break in to your home to get keys so don't make it easy for them.

WHEN to call the police...

Crown Watch's advice on when to call the police and when not to call them but take note of events that you have noticed.

1. When you can see a crime actually being committed or when you can see someone being hurt or threatened - CALL the Police on 999
2. When you see a suspicious vehicle

Keep an eye on the vehicle and its occupants but do so without putting yourself at risk. If you can take a note of the vehicle registration number with the date and time you saw it. If the vehicle drives in, around and out then unless there is something clearly amiss there is no need to call the police at that time.

3. Scrap Metal Collectors

There is no doubt that some of these are unscrupulous but whilst they may annoy residents they are not committing any offence touring around. A visit to the Grove by these does not need to be reported to the police but keep garage doors closed - DO NOT advertise what you possess.

4. Providing information

Most things that you notice each day usually turn out to be innocent. If there is a real suspicious element to them you will usually sense it. So most things that you see and maybe concerned about are best logged and passed onto your neighbourhood Watch Co-Ordinator of the Safer Neighbourhood Team. **If you are in any doubt then call the police on 101 and talk it through with them.**

Kenilworth Update is produced by Crown Watch, one of the longest running Neighbourhood Watch schemes in Kenilworth and Warwickshire. Crown Watch serves the northern end of Windy Arbour, eastern end of Whitemoor Road and Tulip Tree Avenue. It publishes Newsletters and Crime Alerts to its Co-ordinators who circulate these to residents.

Since mid 2011 Crown Watch has been working closely with Kenilworth's Safer Neighbourhood Team to produce **Kenilworth Update**. The purpose of this is to encourage more people to set up and run their own Neighbourhood Watch schemes but also to inform people through an increasing range of channels what is going on in and around the town in terms of keeping our town safe. All of the work is done voluntarily.

Latest Scams

Pop Up Policeman Con

Please be aware of a scam that is occurring at the current time.

You may be using your computer and have an either an image of a policeman and or a message which will state that you have accessed or downloaded unauthorised material and you are must pay a fine. Please do not select or click the message. This is a scam / fraud.

Unfortunately, we have received a report that one person ended up paying a £100 pound fine, hence losing out financially.

Taxman Scam

Another bogus message is one you may get purporting to be from HMRC claiming that you have a tax rebate, the site looks quite genuine

The HMRC state that will never send email regarding tax rebates.

"I Can Fix Your Computer" – "Over The Phone" Racket

Many people throughout the District are being called by so called companies claiming to repair ' Slow computers or remove viruses.

Victims are asked to turn their computer on and are given verbal instructions on how to allow the caller remote access to the computer.

The caller offers to repair the computer for a fee. **"IT'S A SCAM"** The bogus caller asks for bank/credit card details to elicit an online payment.

Payment is immediate and the Scam is complete

Many people are left with their computers not working properly and private data compromised. Victims are left devastated, out of pocket and explaining to their banks why they want to cancel bank/credit cards and change bank account details.

If you leave it on show – away it will go...

Leaving valuables on show in motor vehicles is just asking for trouble. Whether it is in public car park, outside your home in the street or even on your drive. Each of these type of locations has seen such thefts take place in Kenilworth. We know that criminals continue to visit the area to look for the next opportunity. A Sat Nav, a laptop computer, Ipad or even mobile phone. **Leave it on show and away it will go...**

Clarifying UK Speed Limits for cars (and car derived vans up to 2 tonnes max laden)



Applies to ALL roads in built up areas where street lights exist at regular intervals*.
or
Where 30 MPH signs exist in a built up area that is unlit.
*If the speed limit is different to 30 MPH in street lighted areas then signs **MUST** be in place at regular intervals giving the alternative speed limit.



Applies to roads where 40 MPH signs exist at regular intervals. The distance between street lights is now irrelevant so any 40 MPH area must have 40 MPH signs



Applies to roads where 50 MPH signs exist at regular intervals. This limit is becoming more common and is usually found on semi rural single carriageway roads.



Applies to Single carriageways and is the national speed limit for single carriageway roads unless signed otherwise.
Only Dual carriageways & Motorways are 70 MPH.



This is the de-restriction sign that appears at the end of a speed limit area. The national speed limit of 60 MPH applies to Single carriageways with 70 MPH for dual carriageways and motorways

Rules on UK Roads

You must not drive faster than the speed limit for the type of road and your type of vehicle. The speed limit is the absolute maximum and it doesn't mean it's safe to drive at this speed.

A road is only classed as a Dual Carriageway if it has a central reservation or barrier. Speed Limits for Dual Carriageways apply only to roads meeting this description.
